Participation

Each national federation may enter a maximum of 12 fencers. The organising country may enter up to 20 fencers plus the number needed to make up the pools.

Team participation is open to all countries and limited to one team per weapon per country.

Entry

Open to all fencers with valid **2022-2023** FIE License.

No fencer is allowed to take part in the competition unless he is at least 13 years old on 1st January 2022. Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31st December of the year preceding the year in which the competition takes place (cf.o.80). Entries of fencers, teams and referees can only be made at the FIE website, www.fie.org, respecting the deadlines specified in the FIE Rules (cf. o.54).

Entry fees

Individual competition: EUR 25 / Team competition: EUR 150
To be paid on the spot, prior to the competition.

Referee Obligation

Participating countries must be accompanied by referee with FIE A or B licenses as below (cf. t.35). Delegations not respecting the quota must pay a fine of EUR 1000 per referee.

1-4 fencers	No referee required
5-9 fencers	1 referee
10 or more	2 referees
1 Junior team	1 referee

Formula

Individual competitions: one qualifying round of pools, a direct elimination table to qualify for a final by direct elimination (cf. o.35-o.41).

Team competitions: Integral direct elimination with a direct elimination table, which may be incomplete. All places in the table up to 16th place will be fought for. From 17th place onwards teams will be classified, within each round of the table, according to their initial place in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf. o.86); **the remaining ranked teams will be placed in the table by drawing of lots in pairs.** The teams that are not classified will occupy the last places in the table and will be separated by drawing of lots (cf. o.42-o.47).

Doping

Doping control will be done according to FIE rules.

Entering Greece:

For all passengers arriving to Greece:

No longer required to fill out the Passenger Locator Form (PLF)

No longer required to display a valid certificate of vaccination or recovery from COVID-19, or evidence of a negative test result

It only remains mandatory for all passengers to wear facemasks on local public transport (city busses, metro, tram) and in those areas of cruise ships, pleasure boats, yachts and ferries where the use of mask is required, according to the relevant health protocols.

Entering the competition:

All Participants and Spectators inside and outside the venue must wear KN95 / FFP2 facemasks, except fencers and coaches when fencing or warming up.

FIE Covid-19 outline for the season 2022-2023

It was decided that the following measures will be implemented during FIE competitions until further notice:

- Facemasks, except when fencing, training, and eating.
- Participants will need to present to the organizers the negative result of one Covid-19 test (PCR or RAT – Rapid Antigen Test), performed within maximum 72 hours before the arrival in the country.

Other sanitary measures at the competition may be implemented by the host federation at their option or as required by the national authorities.

However, in case the Covid-19 situation would worsen, the sanitary measures will be revised accordingly, and federations will be informed immediately.
