Format Individual tournament
In the first competition of each weapon the initial ranking will be set as follows :
1. FIE junior ranking
2. EFC U23 Circuit ranking
3. The places of non-ranked fencers are drawn randomly
In remaining tournaments the EFC FFE individual ranking will be considered.

Team event
a) In the first competition of each weapon the initial ranking will be set as follows:
3 best initial seeding in individual competition of the team members will be considered.
b) In remaining tournaments the EFC FFE team ranking will be considered.

Rules & Legal The competition is held on the basis of the rules and regulations of FIE and EFC.

Liability Organizer assume no liability. All participants are responsible for the personal equipment.

Jurisdiction By taking part in the tournament, fencers accept the jurisdiction of the FIE, the EFC and of Swiss Fencing.

Anti doping Doping controls may be carried out.
