Referees must be provided based on the total entries per day.

The required number of qualified referees must be entered into the inscription system before athletes can be added to the competition.

The referees activity is not paid by the organizer.

The status quo at the tournament registration deadline is binding for the determination of mandatory referees. The number of referees will be determined/calculated subsequently and will remain the same even in the event of cancellations, even with a medical certificate.

Rules for judges also apply to foreigners per nation:

4 fencers per nation 1 referee

8 fencers per nation 2 referees

The judges must be available for the entire duration of the event.

We expect an adequate appearance:

- trouser suit or skirt
- suit and tie

If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!

Format Registrations must reflect realistic participation! Free cancellation – with or without a medical certificate – is only possible until the rounds are scheduled. After that, the fee must be paid in all cases (even with a medical certificate), and in the event of a non-participation without a cancellation/medical certificate, a penalty fee of EUR 500 must be paid.

The rounds will be published the day before the tournament by 5 p.m. at the latest.
 All fencers will go to their assigned piste 10 minutes prior the start of the competition.



Rules and legal	The event takes place according to FIE and DFB regulations. The award ceremony will be held in the following outfit: - Club tracksuit = Jacket or Shirt and long trousers - Sturdy shoes - Trainers in long trousers
Liability	Organizer assume no liability. All participants are for responsible for the personal equipment.
Jurisdiction	The participants submit to the jurisdiction of the German Fencing Federation e.V.
Anti Doping	Doping controls may be carried out. The participants submit to the jurisdiction of the NADA. The DFB / Organizer is not liable for damages resulting from incorrect performance of doping tests, unless the DFB / Organizer is proven to have acted with intent or gross negligence.
Image / TV rights	The participants and their legal representatives declare that they agree to a publication of their names, clubs and year of birth as the as the competition/event data. The fencer / legal representative declares his consent to the production, distribution and display of images, sound and film during the competitions/events. This consent is free of charge, has unlimited territorial and temporal validity and applies to the right to the image as well as the general right of personality. It includes all media, but in particular the right to reproduce recordings in print, TV shows and the Internet. There is the possibility, but no obligation, to give the name.
Medical	A doctor is present in the competition site. Only doctors are entitled according to the international statutes to grant medical breaks during the fights.
Equipment	Equipment according to definition DFB. https://www.fechten.org/fileadmin/user_upload/Ausruestungsvorschriften_DFB_gueltig_ab_01.04.2024 Athletes of Russian or Belarusian nationality are still permitted to participate in tournaments, provided they have their habitual residence in Germany and compete for a German club. However, they are prohibited from wearing any national identification unless they have been authorised by the FIE to compete under the identification AIN. They are therefore expressly exempt from the obligation to wear the national identification on the back, but the name must be worn. No start is possible if this rule is violated.
