We expect an adequate appearance: - Ladies trouser suit or skirt - Men suit and tie  If foreign fencers are announced by German clubs for DFB tournaments and they are also in possession of a German licence, they fall under the participation rate for the German club and are therefore considered for the calculation of compulsory judges to be sent!
